A quick note to the writer who raises questions about medical marijuana:

Your questions about medical marijuana in Florida appear to be based upon speculative hysteria and not scientific research.

Medical marijuana in Florida is an exceptionally controlled method of providing care to individuals who must show significant proof that a need exists to receive this type of treatment.

While thousands of people, as you suggest, may apply for medical marijuana, unless an individual meets strict criteria, they will not be approved to receive treatment controlled by the state.

Doctors can write as many prescriptions as they want - and they must be specially state-trained doctors who can legally write these prescriptions - however, until the specially trained state employees review every single case, the chance of illegitimate persons receiving See RANTS, page 7

Emergency Fund

ear Friends, One of the many good things about writing for seniors and senior issues is that it is a topic of concern to about half of us who live in Brevard who are senior citizens. And one thing that truly burns me up is when I read something that is associated with seniors that does not address the pertinent issues.

We are all concerned about the cost of government and the wasteful use of tax dollars. I have written several columns on the topic, researched the expenditure of local tax dollars, and am always interested in uncovering new ways we are misled about use of these dollars.

Recent articles in Florida Today informed us about two new emergency funds, one by the county and the other by United Way. While both need discussing, let's stay with the county fund for this article since it uses tax dollars while the United Way fund uses private dollars.

For several months, we have been treated to various discussions on the county budget and its ability, or lack thereof, to pay for road repairs. This

past April, \$184,942 was cut from the county budget to use for road repairs, along with money gained by eliminating the Community Based Organizations (CBO) fund for nonprofits.

Now the county wants to use the same amount of money from its reserves (tax dollars) to fill the new emergency fund.


While discussing the subject, remember that the county has about 2,300 funded positions, of which about 10 percent remain unfilled at any time (another money source).

According to Ian Golden, Housing and Human Services (HHS) Director, we need this special fund for the people who fall through the cracks in emergencies, such as Hurricane Irma. Most of the money will be used to help resi-See SENIORS, page 7
