Palm Bay water issues stressful, affecting health

A recent Rant addressed problems with Palm Bay Water.

I have paid my water bill every month online since the opportunity became available. I have the dates confirmation number for each and every payment.

About a year ago, I stopped receiving e-bills. I continued to pay monthly by phone and on several calls requested a paper bill. I was told by a rep that a bill had been sent. It never happened.

On a Friday afternoon in December 2016, I discovered my water had been turned off. I was not given any notice whatsoever. I immediately called Palm Bay water and was told the water was stopped for "nonpayment" and I had to pay more than \$200 to have it turned back

Even though I knew this wasn't true, I had no other choice but to pay. Again in January and February an employee came to my door to announce he was turning the water off! I still had not received the promised bill.

I have contacted the mayor, who never returned my calls.

ear Friends. Reflecting back on 2017 causes me great concern regarding support for nonprofits that serve seniors and the frail elderly. Local media and letters to the editor evidence a basic misunderstanding of the role that government funding plays in the ability of nonprofits to help people. In the main, public dollars act as incentive money to encourage nonprofits to develop complementary funding and attract people who will use their services.

To clarify the above, let us look at ways to fund adult day care. The majority of those who need these services are not financially prepared when the need arises. However, government funding can act as seed money to encourage clients to pay part of the cost. I used this method as Director of the Alzheimer's Foundation for many years and it worked.

A recent writer to Florida Today commented that government needs to

be out of the funding cycle, at which point churches, local donors, businesses, etc. would become funders. Having been involved in this work for 27 years, I can assure you this will not happen. Churches and many charities already have a purpose to which their funds are directed. Such letters mislead the uninformed and create false perceptions of how we need to prepare for an increased number of elders seeking assistance.

In a Utopian world this would not be a concern, but we live in a changing world, a world in which everyone can not save for the future and more people will need help. The recent act of the county commissioners to defund the Community Based Organization See SENIORS, page 7

funding for nonprofits is an ill advised move. People will be hurt.

For 2018, my New Year's resolution is to continue to promote the needs of seniors in a way that will cause both private and government funding sources to financially support the work of nonprofit organizations that assist seniors and the frail elderly. We forget that Brevard County has more seniors than children, but the majority of funding is directed to youth. For instance, the 2015 school tax has raised more money than expected, but have any of us seen the areas to which these monies are directed?

In 1965, President Johnson spearheaded the Older Americans Act, which provided federal funding to assist the

elderly. I saw the good this money could do if used as intended. Funding of nonprofit services must be better understood, managed, and utilized. We need a County Aging plan to develop both private and public resources to support our rapidly growing senior population. To think otherwise is to ignore a need that cannot be ignored.

We should be concerned. Read some of the history of the social service movement in the United States, and you will see that religious efforts identified this problem many years ago. Perhaps we can move forward with better planning in 2018.
